

# PARAMEDIC PROGRAM APPLICATION PACKET

## **COURSE CONTENT**

The Dakota College at Bottineau (DCB) Paramedic Program is rigorous and time demanding. There will be classroom sessions concurrent with both hospital and field clinical time and culminated by a capstone internship. During your paramedic education you will become certified in Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), and Pre-hospital Trauma Life Support (PHTLS). At the completion of your paramedic training, you will be eligible to sit for the National Registry of EMT's Paramedic Certification Exam.

#### **COURSE DURATION**

The program starts June, 2016 with anticipated completion August, 2017. The program runs continuously through the summer, fall, spring and summer academic semesters. Students must successfully complete all courses each semester to progress into the next semester of class. The student will be held to strict academic and attendance guidelines. Hospital and Field (Ambulance) clinical experiences are gained concurrently throughout the academic year with affiliated agencies.

## **APPLICATION CRITERIA**

Application requirements for this program include:

- 1) You must be at least 18 years-old at the beginning of the course.
- 2) Current NREMT, NREMT-Intermediate or NRAEMT at time of starting paramedic program.
- 3) Two letters of recommendation.
- 4) Current Health Care Provider CPR certification.
- 5) Current on immunizations (Hepatitis B, Tetanus and TB test) at time of starting paramedic training.
- 6) Valid driver's license.

Information for submitting the background check is found at this link: www.CertifiedBackground.com, in the place order box (orange) where it asks for the package code, enter: MI70 (that is: letter, letter, number, number). Select a method of payment: Visa, MasterCard or money order. The price will be determined by the number of states that you have resided in.

You also must meet all admission requirements of Dakota College of Bottineau, which includes a separate application process. #### **APPLICATION DEADLINE**

Applications must be completed by April 15th, 2016 for consideration to the incoming class. After review of applications, notices will be mailed informing the applicants of the dates and times of class orientation.

## ACCEPTANCE CRITERIA

Each candidate's application will be reviewed and the applicant's attitude, professionalism, motivation, dependability, reliability, ability to communicate verbally, and desire to follow orders and readiness for the program will be evaluated during class orientation. Individuals <u>must</u> submit the following documentation <u>no later</u> than April 15th, 2016:

- 2) Photo copies of current;
  - a) Drivers License
  - b) NREMT Card
  - c) American Heart Association Health Care Provider CPR Card
- 3) Background check application/fee
- 4) Two Letters of Recommendation
- 5) Acknowledgement of Course Demands
- 6) Confidentiality Agreement
- 7) Application and Acceptance to Dakota College at Bottineau
- 8) Immunization Status (Hepatitis B, Tetanus and TB test)
