



Course Prefix/Number/Title: EMS 275 – Introduction to Clinical Experience

Number of Credits: 2 credits

Course Description: This course is designed to introduce the paramedic student to the clinical settings where a paramedic may work. The student will also become familiar with procedures and care of patients as well as apply learned classroom/lab skills and knowledge in these patient care settings. The student will function under the direction of a preceptor. The student will input patient contact information into the Platinum Planner system. The student will also gain knowledge of how the 911 system works by observing at Minot Central Dispatch and the City Police Department.

Pre-/Co-requisites: EMS 208 Introduction to Emergency Pre-Hospital Care

Course Objectives: To introduce students into the clinical setting of the emergency department. The student will perform skills at their current EMT/AEMT level as well as more advanced skills as they are learned in class and lab.
