Tentative Course Outline: There are modules to be completed through Blackboard Ultra. Within these modules, the following assigned points are accounted for:

Classroom Observation (student will observe a teacher's classroom for 30 hours)	300 pts
Observation Reflection Paper: students will write 4 reflections, each one detailing an aspect of their observations (see Course Objectives)	4x10 pts= 40 pts
Personal Philosophy Reflection (A Look at my Class)	30 pts
Praxis Research (locate information on which Praxis test you will need to take to gain licensure, locate state test requirements to become a licensed teacher)	30 pts
