

EDUC 101 – Introduction to Paraeducation

1 Credit

Course Description: This course will provide the students an overview of the field of paraeducation. Topics include roles and responsibilities of a paraeducator, professional and ethical conduct, federal and state educational policies, creating a positive and safe learning environment, understanding the diverse needs of students, interacting with families, managing behavior, collecting data on student progress, and working collaboratively as part of a team.

- Understand the characteristics of students with various disabilities
- Discuss the role of IDEA in the education of students with disabilities
- Define the roles and responsibilities of a paraeducator
- Identify interventions to strengthen behavior

- Identify the principles of effective instruction
- Understand the principles of inclusive education
