

Course Prefix/Number/Title: HPER 151 – Varsity Sports (Softball)

Number of credits: 1

Course Description: This course requires a full semester of participation in varsity softball. The fundamental skills and basic strategies of softball will be taught through teaching, practicing, and playing the game of softball. On and off field lessons will be given.
